



TERMES OF REFERENCE NATIONAL FORESTRY AND REDD+ EXPERT

For the recruitment of a Consultant-National Forestry and REDD+ Expert to support the preparation of a GCF Project in Cameroon.

1- Location : Cameroon ;

2- Background :

IUCN is a membership Union uniquely composed of both government and civil society organizations. It provides public, private and non-governmental organizations with the knowledge and tools that enable human progress, economic development and nature conservation to take place together. It harnesses the experience, resources and reach of its more than 1,400 Member organizations and the input of more than 17,000 experts. Our experts are organized into six commissions dedicated to species survival, environmental law, protected areas, social and economic policy, ecosystem management, and education and communication. This diversity and vast expertise makes IUCN the global authority on the status of the natural world and the measures needed to safeguard it.

IUCN and the Government of Cameroon are requesting funding from the Project Preparation Facility (PPF) to prepare the “*Securing Permanent Forests to Combat Climate Change and Enhance Sustainable National and Local Economies in Cameroon*” project. The project will address the main problem of permanent forest areas (PFAs) which is deforestation and forest degradation. It will also focus on addressing deforestation and degradation of Cameroon's permanent forests, and unexpected changes in land use systems in Permanent Forest Areas (PFAs). The objective of the project is to reduce degradation and land use change in permanent forests in order to combat climate change and promote national and local economies in Cameroon. It includes the following three components: **Component 1:** Sustainable forest management and restoration; **Component 2:** Capacity building of stakeholders; **Component 3 :** Market development and supply chain transformation and **Component 4 :** Project Management, Monitoring and Partnership. The project will focus on permanent forest located in three selected eco-regional landscapes in Cameroon: South – East Moist Forest; Bakossi – Bamboutos highlands and Farh North Region (soudano-sahelian).

3- General Scope :

The implementation of the project will require IUCN to recruit a National Forestry and REDD+ Expert to support the elaboration of feasibility studies and the full project proposal of the above project, notably to collect field data, support stakeholder consultation, facilitate contacts between a Consultancy Firm and other international experts. The National Forestry and REDD+ Expert will work closely with other national consultants like the Carbon Stock Evaluation Expert, Socio-economic Expert, GIS Expert to ensure that they gather the required data in the Project sites (South-Est Humid forest, Bakossi – Bamboutos Landscape, Far North Region) in a coordinated matter.

4- Specific Tasks

Under the supervision of the international Consultancy Firm, IUCN and the Government of Cameroon, the Consultant will:

- Collect and compile data on the Cameroon forest sector, notably on the the Cameroon forestry domain and its economic and spatial importance, past, present and future financial flows of the sector, policy and legislative analysis, etc.
- Collect most recent data on forest dynamics and drivers of these dynamics ;

- Participate in the analysis of the economic impact of the forestry and REDD+ sectors;
- Facilitate contacts between the International Consultancy Firm and national institutions and actors, notably on forest and REDD matters
- Collect data on financial flows on the forestry and REDD+ sector, current initiatives, achievements, challenges and lessons learned;
- Support i the organization of technical workshop to discuss and validate the outcomes of the feasibility studies, including forestry and REDD+ data;
- Contribute to the analysis of potential benefits and co-benefits in the forest and REDD+ sectors ;
- Identify and engage private companies in the activities of the project to facilitate transformation and upscaling of results;
- Analyse and identify pathways and mechanisms to prevent double payments on results within the framework of REDD+ RBP;
- Analyse and highlight the opportunities for payments from REDD+ and the voluntary markets to support a further scale up of the PFA;
- Undertake other tasks requested by IUCN.

5- Qualifications

- At least an MSc/MA in Forestry, environmental sciences, social sciences, geography or equivalent;
- Excellent knowledge of forestry and environmental policies in Cameroon and Central Africa ;
- Good knowledge of the REDD+ process and its institutional and policy dynamics in Cameroon, Central Africa and beyond;
- Good attention to details and the capacity to understand global environmental strategies as well as IUCN and GCF vision on conservation;
- Good knowledge on donor policies in the conservation and climate change sectors;
- Good communication skills and ability to work as a team with a group of consultants and international staff;
- Good knowledge of English and French.

6- Start and end dates :

May 15, 2021 to May 14, 2022. The project is funded by GCF.
